1. Bank Mortgage Presentation – Mark Shantzis – Mark Shantzis presented a mortgage analysis over a 7-year period with two banks as part of the process to refinance the mortgage of the Odyssey Eldron campus to lower the interest rate.

E. MANAGEMENT COMPANY REPORT

- 1. Odyssey Space Coast Academy Update We were in lease negotiations with Unity Church, which philosophically aligned with school. Unity decided not to move forward with lease negotiations. We have one facility that we are looking at, but it looks as though we may not be able to open Odyssey Space Coast Academy.
- 2. Rachel Roberts Constance Ortiz explained that Dr. Revis will be moving back to Las Vegas and will not be returning to OPA as Site Administrator next year. The team has found and is recommending Rachel Roberts and the new Site Administrator for Odyssey Prep. She has an early literacy background, mentor teacher for DOE in Washington D.C. Her strong knowledge in Reading and assessments will enhance what OPA team has been working on.
- 3. Mediation with BPS The Board was updated on the final outcome of the mediation between Odyssey Charter School and Brevard Public Schools.

F. ADMINISTRATOR REPORT

- 1. Odyssey Charter School Odyssey Charter School has been awarded the Green Ribbon School Award, which is a nationally recognized award presented by the Secretary of State! Brought 3-6th grades into the Café to listen to the announcement. They were very excited and it was meaningful. Beginning SIP review with teachers and have them working on goals for next year. Jr./Sr. building the High School. Have master schedule and have dual enrollment in the works. Auqaponics lab being built on the property. 5K Run at the Wyoming campus this Saturday the 25th. Leslie Maloney, Board President has spearheaded a partnership with Sierra Club to blaze a trail through the forest on the Wyoming campus.
- 2. Odyssey Preparatory Academy Dr. Revis presented the benchmark mastery and cold assessment results for OPA. Results show gradual improvement for all grades in Math and ELA.
- 3. Oasis Preparatory Academy FSA testing is almost complete. On-site compliance review coming up next month. Study Island benchmark testing results looking very positive. K-2 will begin Iowa testing soon. There was Study Island contest out of 763 schools, Oasis placed 6th. This was a 5-day contest and Oasis only was able to participate in 3 of those days due to assessments.
