A. OPENING EXCERCISES

- Call to Order & Establish Quorum Dr. Jane Martin, Jessicah Nichols, Thomas Cole and David Back were present; Cliff Repperger was not present.
- Pledge of Allegiance
- Adoption of the Agenda After additional agenda items were added, agenda was unanimously adopted under one motion by Jessicah Nichols; seconded by Jane Martin
- **B. PUBLIC COMMENT** (Members of the public that wish to address the Board must sign-in and will have 3 minutes to speak. The Board will not address the presenter or take action at this time)

C. INFORMATION

- 1. 2014-2015 Teacher Employment Agreement revisions Constance mentioned that the schools are having difficulties with teachers not fulfilling their contract requirements. Leadership is working with the school's attorney to make the 2014-2015 Teacher Employment Agreement more substantial with additional language.
- 2. Oasis Preparatory Academy Principal Candidate Ms. Valerie Thompson Constance has been talking with Ms. Thompson for over a year. She is familiar with community and has many years of leadership experience and strives for excellence and accountability. Leadership would like to recommend Ms. Thompson for approval as Principal for Oasis at the next Board meeting. Ms. Thompson interviewed with Constance Ortiz, Pastor Mills, and the Head of M.I.L.L.S. Academy. She will be meeting Dr. Jane Martin soon.
- 3. Prospective Orange County OCS Board Member Ms. Sonja White Since the Oasis contract states that Board will need to add two new members who are residents of Orange County, Dr. Jane Martin and Constance Ortiz interviewed Ms Sonja White as a prospective OCS Board member. Ms. White is a retired police officer in Orange County. She is committed to, and has a deep connection in the community that surrounds Oasis. Jane Martin stated that Ms. White is very verbal and compassionate. She has a huge network and seems like she would be a strong asset to the OCS Board.

E. MANAGEMENT COMPANY REPORT

- 1. Amended Budgets Constance briefed the Board on the amendments to the 2013-2014 budgets for OCS and OPA.
- 2. 2014-2015 District Funding Changes The OCS Board Members discussed the future funding payment change with the school's attorney and the school's management company.
- 3. New Schools Update Constance Ortiz gave an update to the Board on the new schools. Oasis is coming along on track. So far we have 85 applications. Marketing is underway. Odyssey Space Coast is in the beginning, planning phase due to the late approval. We are working on obtaining a facility.
- 4. Charter Contract Amendments Cindy Gilmore briefed the Board on the requested contract amendments for all schools.

F. ADMINISTRATOR REPORT

- 1. Odyssey Preparatory Academy As of the February 2014 FTE, OPA has 76% Free and Reduced Lunch, with a Minority of 60%. This is the first year that the State will be grading charter schools in their first year of operation. The 2012-2013 FCAT scores of the OPA 4th-5th graders averaged 58% proficient in Reading, and 30-35% proficient in Math. Immediately interventions were put in place. Successmaker has been implemented as an intervention, as well as Math tutoring. MAP results were low. Interventions continued along with additional support in the classrooms. Successmaker reports schoolwide in 6-7 weeks showed 2 months growth in Math, and almost 2 months growth in Reading. Working on building the culture and hoping for a B this year. It will take a couple years to stabilize.
