1. Management company report - Constance Ortiz announced that GA has received AdvancED accreditation, so every school currently operating or opened in the future by OCS, Inc., will be accredited as a "Green Apple" school. Congrats to OCS, Inc., as they now own the Wyoming Campus building. Bond process for both campuses was a lengthy and time consuming process but went relatively smoothly. Student assessment scores have been released. After analyzing the data, it is looking like OPA will possibly B grade, OCS will possibly receive either an B or A grade. We believe Oasis will receive a failing grade according to the current scores released. The scores look like they will not be able to stay open. Constance shared the struggles at Oasis; 50% turnover each year, getting new students with grade levels forming that were between 6.5%- 14% at grade level, and finding a high-quality teaching faculty. management company and the OCS leadership team supported the school with additional support personnel, a principal mentor, coaches, and resources to try to increase student achievement, but we were not successful in making enough of a difference to satisfy the requirements of the Florida State Assessments. No Board action needs to be taken at this time until the grade is released. Beth Crist reviewed the Oasis end of year closing entries with the Board, which includes reducing the Mt. Sinai recoverable grant by reclassifying the \$12,500 of rent credits due to Oasis for initial building improvements, as well as, a partial payment back to Green Apple School Management for \$8,541.67 of uncollected management fees recorded to a recoverable grant. The loan to the school from Odyssey, Inc., will be paid in full by year end. In addition, we are requesting that some minor expenses paid for by GA for Orion Brevard and Orion Orange be reimbursed by OCS, Inc.
