D. MANAGEMENT COMPANY REPORT – Constance Ortiz shared some information with the Board regarding the Equitable facilities fund (Waltons) discussion. Constance also reported the school grades to the Board. OCS received an 'A' grade, and OPA received a 'B' grade. OPA missed an 'A' by 7 scale points or 1 percentile point. Also, with the schools being 80% poverty and 50% minority, the OCS is at the top 7% of Title I schools, and OPA is at the top 10%, and top 2% in of Title I schools in the district above 70%.

- 1. Liability insurance coverage Security Guardian and SRO Cindy Gilmore updated the Board as to the progress of adding the liability coverage for the Guardian and SRO to the current liability coverage. The applications have been completed and we are working on binding the coverage at \$1M/\$1M with a \$5K deductible. We are waiting for the insurance company to provide what the actual coverage entails. Cindy will email an update to Board once received.
