C. MANAGEMENT COMPANY REPORT

1. ESE Discussion – Constance Ortiz reported to the Board the difficulty with now having some ESE students that have a large amount of ESE minutes and cannot function in an inclusive environment. The model is an 80%-20% ESE model. We are having difficulty with the district, as they are requiring our schools to service these children without the proper resources and funding. This will change the inclusion model of the school. Currently there is a dispute with the interpretation of the charter contract. We are seeking clarification from the district and a process. We would like to enter in to mediation.

1. Odyssey Preparatory Academy – School Progress Report, Dr. Reggie Revis – Dr. Revis gave a monthly update to the Board with the current baseline data for Odyssey Preparatory Academy. A slight modification to the schedule in order to create groups with less than seven students. The teachers will be teaching an essential component of reading using resources from FCRR. Behavior intervention is happening with referrals to counseling and MTSS for behavior. PA will begin an introduction to 101 Ways to Teach Children Social Skills; character education curriculum developed by The Bureau for At-Risk Youth.
