- 1. Odyssey Preparatory Academy School Progress Report, Dr. Reggie Revis Dr. Revis thanked Kim Gary, Paulette Brancaccio, and Alexis Rotstein for their work pulling together the assessment information for reporting. Math and Reading has shown improvement through intervention. Study Island data cold assessment results show a general increase in the results from October to November. Intervention groups are formed based on cold assessment Study Island data and teacher input. Depending on the grade level, up to six staff members intervene. Staff/student ratios average between 1:4 and 1:5. Strategies and action steps for 5th and 6th Math; a retired teacher is providing both classroom support and small group interventions. The Reading Coach is providing the same for Reading. Walk through observations and PLC meetings continue.
- 2. Odyssey Charter School Wendi Nolder The school held a Science Night featuring information on the upcoming Science Fair for OPA and OCS. Dr. Martin presented the evening events, and there was a significant parent turnout. The Elementary campus will be holding a Math night tonight.
